



2019 Frontier Days Rules & Regulations

Listed below is information that you need to read about and adhere to during the festival. If you have any other questions not addressed, please call 432-889-8359 or email us at santaanna.wcbc@gmail.com.

Entry Forms: Signed entry forms must be received with payment. \$20.00 late fee applies after May 6, 2019. No vendors will be accepted on the day of the event. No refunds rain or shine! No refunds for cancellations after April 1, 2019. \$30.00 fee for returned checks.

First Time Vendors: Must submit a photo of booth along with application to be considered

Sales Tax: Vendors are responsible for collecting and remitting sales tax for any sales you make. Your tax ID must be on display at all times in your booth. If you show up without a permit you will be turned away and you will receive no refund.

Set-up Time: Noon until 7 pm, Friday, May 17, 2019 and 7 am to 9 am, Saturday, May 18, 2019

Hours of Operation: 9 am until 4 pm, Saturday, May 18, 2019. You must stay for the entire event. If you leave early, you will not be welcomed back.

All Booths: All vendors are responsible for set up and take down of your booth. You will also be responsible for your own canopies, tables, chairs, extension cords, etc. A professional sign stating the name of your business or the items you are selling must be on display in your booth. Some poster board signs can be used for menus, etc. All tables need to be covered. No smoking in booth areas and no pets.

Craft Booths: Must be 100% hand-made items. No manufactured or imported items in craft booths.

Commercial Booths: For new manufactured or imported items. No snappers, poppers, silly string, water, cork or dart guns. No smoke or stink bombs or exploding items. No sharp or dangerous toy like swords or knives. No used or garage sale items. This is not a flea market.

Food Booths: Food booths are limited to local clubs or organizations. The only exceptions are unusual food items not sold by local groups. Our goal is to not duplicate food items and will accept food items sold on a first come basis. The Frontier Days Committee reserves the right to sell Barbeque. It is a tradition since 1994 that Bison Brisket plates are sold from 11:30 until 1:30 as part of the World Championship Bison Cookoff.

Submission does not guarantee acceptance. Applications will be reviewed as they are received. Entry fee will be promptly returned if not accepted.
